Directions to virtually raise hand on a DESKTOP/LAPTOP/SMARTPHONE: • Click on the “**Raise Hand**” icon on the bottom of the screen. This will signal to the host that you would like to provide public comment and you will be added to the list.

Directions for TELEPHONE line only: • Dial ***9** on your keypad to signal that you would like to provide public comment.

Phone controls for participants:

The following commands can be used on your phone’s dial pad.

- *6 - Toggle mute/unmute
- *9 - Raise hand
