# Operational Update

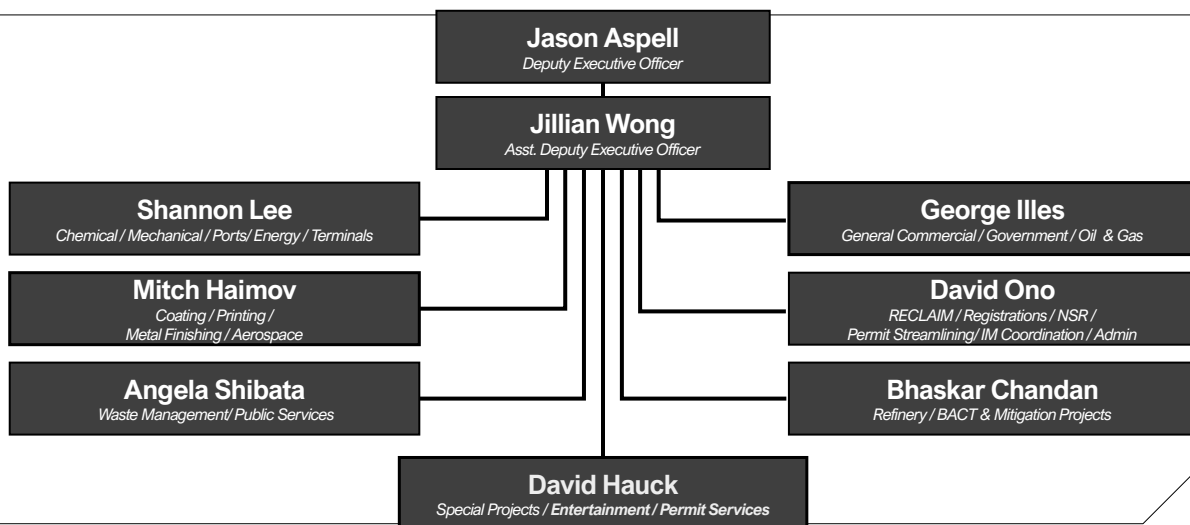
## Recruitment Update

- Continual recruiting, interview, and promotional efforts
- Since January 2024 update:
  - 3 hires (Engineers)
  - 5 promotions
  - 1 reassignment (Supervising Engineer)
  - 3 Working Out of Class Senior Engineers
  - 1 Working Out of Class Supervisor
  - 3 separations (Engineers)
- Current E&P vacancy rate: 9.1%
- Targeted E&P vacancy rate: below 10%

## Updated Productivity Metrics

- Fiscal Year (FY) 2023-24 Priority Objective and Goal of timely completions has been replaced in FY 2024-25 to focus on increasing permitting production
  - Met FY 2023-24 timely completion goal in each of the four reported quarters
  - FY 2024-25 goal to increase production by 500 completions over CY 2023
- Monthly report to Stationary Source Committee
  - Provides information on permit application workflows
  - Renewed focus on monthly completions to:
    - monitor new staff and new supervisory staff development
    - track staff production in returning to pre-pandemic levels

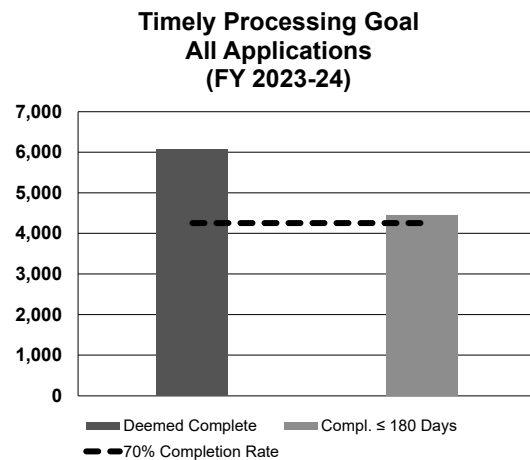
## E&P FY Goal and Priority Objective

### FY 2023-24

- Maintain current completion rate of 70% of permit applications within 180 days of being deemed complete, measured quarterly
- Met or exceeded target for each quarter and the entire FY

### FY 2024-25

- Increase production by 500 completions as compared to 2023
- Goal of 5,865 permit completions
- Measured and reported quarterly

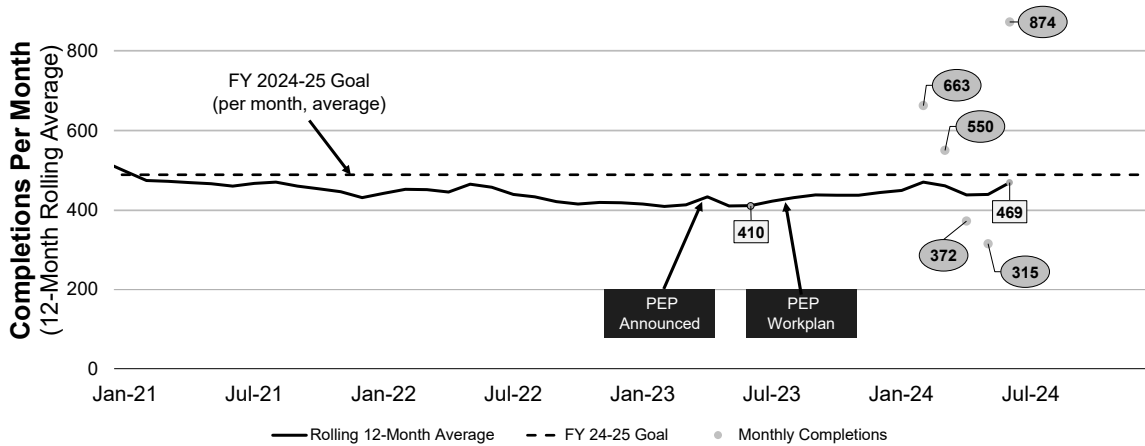

## Monthly Annual Average and Recent Monthly Totals



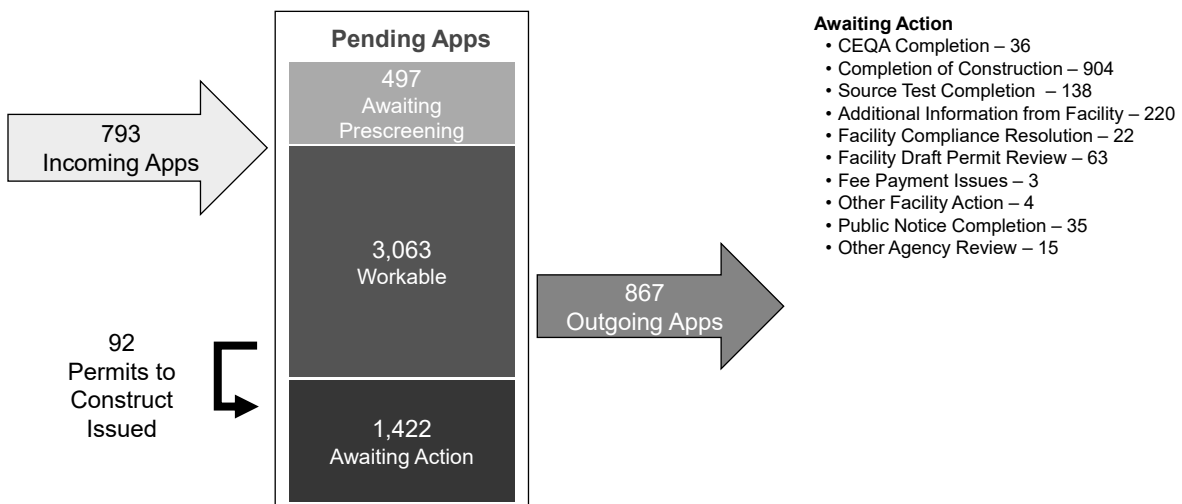

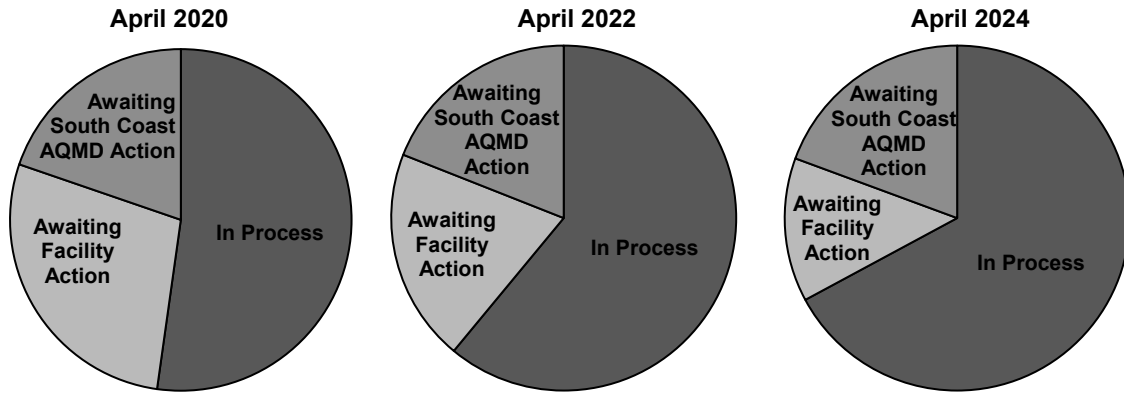
## June 2024 Application Workflow (July Report Period)

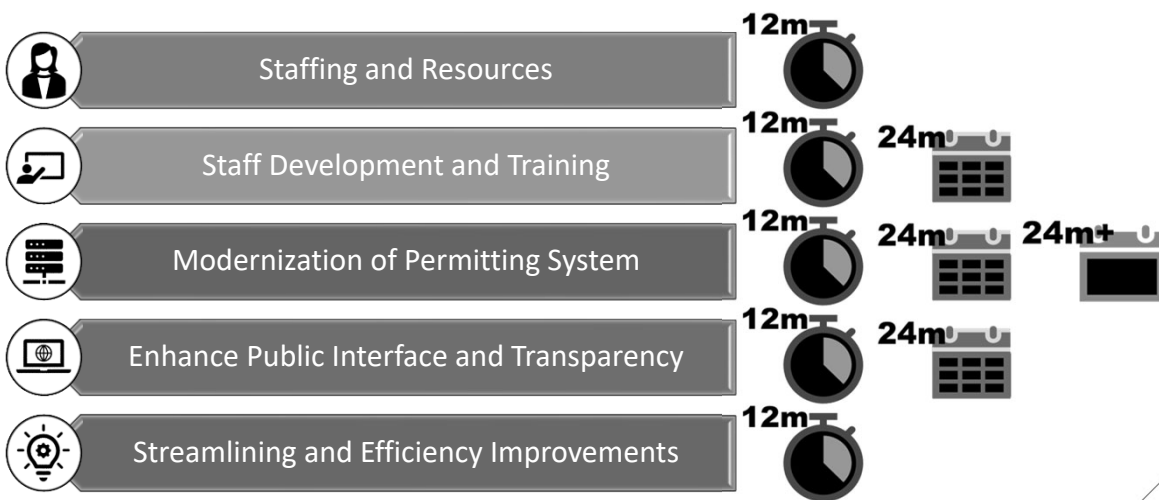


