South Coast AQMD Issues Windblown Dust Advisory for Portions of the Eastern South Coast Air Basin and the Coachella Valley

Valid: Wednesday, May 19 through Friday, May 21, 2021

This advisory is in effect through Friday. South Coast AQMD will issue an update if additional information becomes available.

A PM10 Dust Advisory is in effect on Wednesday, May 19, 2021 due to predicted high winds in the Eastern South Coast Air Basin and the Coachella Valley.

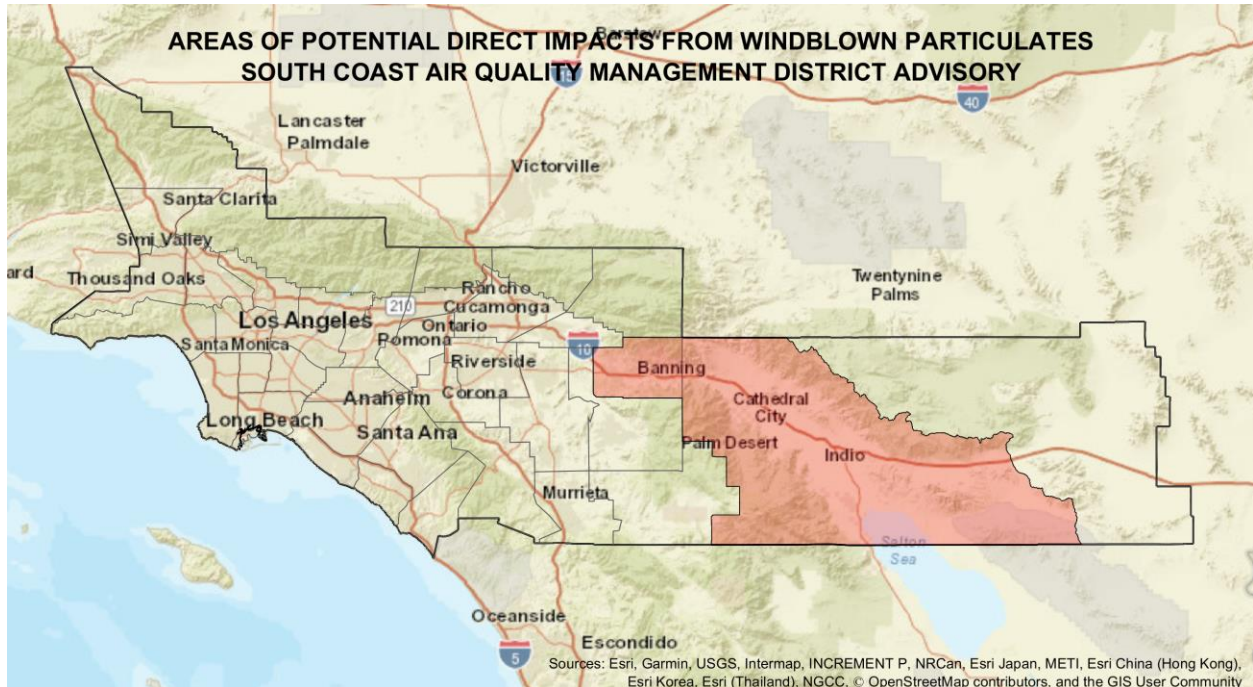
The National Weather Service (NWS) has posted a Wind Advisory for the San Geronio Pass near Banning and the Coachella Valley that is in effect from Wednesday at 12:10 p.m. through Friday at 11:00 p.m. For information regarding the NWS warnings, please visit the NWS San Diego (<https://www.weather.gov/sgx/>) website.

Winds from the west with gusts up to 55 mph are expected in the mountains and deserts. Areas of blowing dust and sand are predicted throughout this wind event, which may result in **Unhealthy for Sensitive Groups or higher** Air Quality Index (AQI) levels in the San Geronio Pass area and the Coachella Valley. Localized areas of blowing ash are possible in areas near the 2020 wildfire burn scars.

In areas directly impacted by windblown dust and ash: Limit your exposure by remaining indoors with windows and doors closed and avoiding vigorous physical activity.

Areas of direct impacts and poor air quality may include portions of:

- **Riverside County:** San Geronio Pass (Area 29), Coachella Valley (Area 30)
